Comment

It was observed in this inspection that revegetation of interim areas is not progressing towards COGCC 1003's 80% uniform, desirable vegetative cover requirements. Records show wells have been in production since 2011; at least 9 growing seasons have passed.

 Some desirable perennial establishment observed, however, the dominant plant species observed established on interim areas were undesirable weedy annual grass species such as cheat grass.

Corrective Action

Comply with 1003 rules and conduct additional reclamation on interim areas of the Location. Continue to monitor and manage interim areas to ensure vegetative establishment progresses towards Rule 1003.e.(2) 80% uniform, desirable vegetative cover requirements, and ensure control measures are implemented to stabilize the seeded soil.
