New corrective actions in addition to CAs per Inspection #700702540:

Stormwater erosion degradation observed on interim areas of the Location, and areas adjacent to the access road; control measures to stabilize interim areas are missing or insufficient; stormwater control measures to allow for sediment laden stormwater discharge are missing or insufficient; stormwater diversion ditches along the northern perimeter of the Location and access road have not been constructed with appropriate outlets in accordance with good engineering practices; sediment traps observed not constructed in accordance with good engineering practices.

Corrective Action: Install or repair required BMPs per Rule 1002.f.(2)C. Ensure control measures are adequate for the site's conditions, installed in accordance with good engineering practices, and maintained in proper functioning condition.
