Comment: There is vehicle rutting along the main road. There are areas of the road that are not stabilized and stormwater is not properly diverted. Repairing the road only by grading is not sufficient. Areas of erosion along the road needs to be repaired and properly stabilized. This issue has been previously observed and needs to be prevented. BMP's must be implemented in accordance with good engineering practice and must be maintained. Previous corrective action has not been completed.
