Operator has performed final reclamation activities with the evidence of some establishment of desirable species. However, a List B Colorado noxious weed, Scotch thistle, was observed in the rosette growth stage along the access road and well location.

Reference area vegetation is mostly comprised of Cereal rye.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
