Due to seed dispersal being allowed and the onset of winter conditions resulting in plant dormancy, any weed management activities conducted will likely be insufficient until the 2021 growing season.

Therefore, no corrective action date is being provided in this inspection; this Location will remain out of compliance with Rule 1003.f until a followup inspection is conducted documenting that sufficient weed management activities have been performed to prevent the establishment and spread of noxious weeds:

Operator Comment: "All thistle were cut and bagged. Seed thatch from under plants was also bagged. We made sure to get as many seed heads as possible. Heavily infestation areas were sprayed with Milestone to take care of any rosettes and emerging rosettes. There were several second year Houndstounge that we also bagged up." (Photos in attachments.)

For continuing weed management Berry plans to have the site visited at least 3 times by noxious weed management professionals with inspections planned to generally fall in mid-May, the end of June, August, and possible late September for assessment and any necessary treatment activities. While on site the personnel will walk the reclaim area in a tight grid pattern to assure every plant that is emerged is sprayed. Milestone herbicide will be used to ensure best results. Pictures will be taken during each visit to show current status and the results of ongoing treatment activities.
