This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad, there is no evidence of a tracking pad at time of inspection.

C/A's from previous inspection document # 700702150 have been satisfied.

During this inspection the following compliance issues were observed:

1. Lack of tank battery signage.
