Corrective Action:	<p>In response to the previous corrective action FIR, Operator completed final reclamation activities on 7/9/2019 and removed the debris.</p> <p>Based on this inspection, it does not appear the Operator has been monitoring this location based on the establishment and density of undesirable and noxious weeds (List B Colorado noxious Scotch thistle). Desirable establishment was observed but a majority of the location lacks the establishment of desirable vegetation which is not reflective of reference areas.</p>	Date 05/25/2021
	<p>Comply with Rule 1004 to control and manage noxious weeds and perform additional reclamation activities. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>Since noxious weeds were observed, the corrective date is the date the location was observed out of compliance.</p>
