**General Comment:****COGCC Inspection Report Summary**

On Wednesday at approximately 1000, I, Inspector Scott Ramsey, conducted a routine inspection at XTO Federal 2S-95-15-42BP, at Location # 316614 in Rio Blanco county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Also within BLM stipulations area.

During this inspection the following possible compliance issues were observed:

1. Cut slope on location shows signs of lack of stabilization.
  2. Lack of battery signage.
  3. Debris at well head
  4. One (1) dead man is not marked properly
  5. Hole in tank battery containment
  6. Unused equipment (dehy is disconnected and not in use)
- Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
