Operator has failed to complete all reclamation work; gravel remains and the location has not been re-contoured or re-graded; weedy, annual vegetation was observed which is not reflective of reference area vegetative levels.</p> <p>Note: Remediation efforts started approximately one year prior to plugging operations.</p>	Date 08/17/2019
