#### COMMENTS:

COGCC Permitting Group Review dated May 26, 2021 identified a concern related to geologic formations applicable to Wexpro Company's variance hearing application for the Wilson, F. #3 Well (API 05-081-5577) ("the Well"). Specifically, the review notes a concern that the "[r]ecords indicate the Well is producing from both the Wasatch and Fort Union formation." Wexpro has conducted a thorough review of the Well's records and has confirmed that the Wasatch formation is the only producing formation at the Well. Additionally, the Fort Union Formation has never been capable of producing at the Well and the Wasatch has been the only producing formation at the Well since drilling began in 1934. The discrepancy in COGCC's records likely relates to an error in a Sundry Notice submitted to the Commission in 1986, attached, in response to COGCC's effort to computerize historic wells files in the 1980s, attached. Wexpro Company request the Fort Union interval be removed.
