I want to thank you for the batch of Form 4's you recently sent covering part of the 12N-100W area.

I have been working on a special project here at the Commission for the last year, putting into the computer all the wells in Colorado. Currently we are concentrating on all wells that are not plugged and abandoned.

Recently I came to the 12N-100W area. Due to the age of the Hiawatha Fields, many well files are missing or incomplete.
