Cracking in berms needs to be monitored and stabilization measures employed if cracks deepen or slipping occurs. Stormwater controls need to be installed using good engineering practices such as those described in CDOT manuals for stormwater and erosion control.

Operator Comment: As mentioned in previous FIRRs, monitoring of the berms was implemented immediately following the original corrective action in 2019. In SG's observation, the cracks did not deepen and slipping has not occurred. However, the new COGCC inspector decided the corrective action has not been met. Therefore, SG conducted additional measures to fix the cracks (see photos). Outlet protection has been added to the off-pad stormwater settling ponds (see photos). Additional stabilization measures are planned to be implemented as well.
