Comment: The access road remains per approved variance request but will require additional stabilization. The vegetation appears to be progressing at the location but there are areas that could use additional reseeding. There are noxious weeds in areas of the location. The weeds are beginning to develop seed heads and need to be controlled before further spreading. There are straw bales around the perimeter that have degraded. The bales should be removed or replaced if needed.
