On Thursday 6/24/21 at approximately 12:30 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at BERRY PETROLEUM COMPANY LLC CHEVRON D20 696 /, Location #335161 in Garfield County Colorado. While there, I observed normal production operations. During this inspection the following compliance issues were observed:

- 1) No battery sign located at the tank battery with a corrective action date of 9/24/21.
- 2) Location lacks stabilization. No form of tracking BMP at entrance to location with a corrective action date of 7/9/21.

- The Location is located in a high priority habitat area. Additionally the location and access road is approximately 800 yards from Parachute creek. All drainages from location contribute to Parachute Creek.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
