Comment: The location is being farmed around and has not been returned to cropland production. It does not appear the soils have been leveled and decompacted. There are undesirable weeds and areas with no vegetation growth which indicates possible soil issues. A soil analysis should be performed to evaluate soil conditions. The location needs to be reclaimed to reestablish a uniform crop cover. Corrective action needs to be performed immediately to obtain compliance.
