During this inspection the following compliance issues were observed:

1) Location lacks stabilization. No form of tracking BMP at entrance to location with a corrective action date of 7/9/21.

- The Location is located in a high priority habitat area. Additionally the location and access road is approximately 460 feet from Parachute creek.

A follow up on this site inspection needs to be conducted to ensure the  
Compliance issues have been corrected to comply with COGCC rules.
