	Until such time as this well is abandoned, operator shall perform mitigation efforts to alleviate bradenhead pressure. Shut in bradenhead pressure shall not exceed 50 psig.
	1. Operator will implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well operations do not constitute a nuisance or hazard to public welfare. 2. Prior to starting bradenhead mitigation, if a sample has not been collected within the last twelve months collect bradenhead and production gas samples for laboratory analysis. Sampling will comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results will be provided to the COGCC within three months of collecting the samples. 3. Operator will implement measures to get an initial estimate of the gas flow rate and/or volume from the bradenhead. During the shut-in period record pressure data to adequately characterize the build-up. This mitigation plan may be used for six consecutive months from the date test reported on the Form 17. 4. By 11/14/2021 this well must be plugged and a final form 4 sundry filed documenting mitigation efforts up until the time of abandonment. The sundry should include details of the sample analysis interpretation, and the flow rate information and pressure data.
