Field Inspector Actions:
On 6-24-21, I Tom Beardslee area field inspector was assigned a complaint received by COGCC staff in reference to noise. The complainant (Dennis Scheider 23017 Eagle Ct., Aguilar, CO 81020) stated the issues were occurring outside of complainants home.
On 6-28-21 I attempted to perform a complete site inspection of the oil and gas location and associated wells in the area. Was unable to perform sound study due to weather conditions.
On 7-7-21 I was able to perform a complete inspection of the oil and gas location and associated wells in the area. COGCC noise survey results indicate noise levels exceed limits in Rule 423.(due to terrain sound meter was set 63' to the north of source, calculated db was 68.9 I also observed a mechanical issue on the sound mitigation device (muffler) installed on compressor motor. See inspection Doc. #6935104513 for details.
Weather conditions: 63 degrees, clear skies
All information reviewed and site inspection information were submitted to the COGCC for further review.
