**General Comment:**

On 7/12/2021, Reclamation Specialist Trujillo conducted a stormwater inspection at Laramie Energys Cascade Creek 697-09-61 Location in Garfield County, Colorado.

This inspection is also a followup to:

and 696202122 dated 12/8/2020 to document compliance with the following corrective actions:

1002.f: Stormwater

It was observed in this inspection that the Location remains out of compliance with COGCC Rules and Corrective actions.

Comment: Previous inspections observed that BMPs were missing, or insufficient to stabilize/protect the cut slopes on the north and western areas of the location, and required Operator to comply with 1002.f rules. Operator submitted FIRR No. 402706390 stating CAs have been addressed.

It was observed in this inspection that Operator implemented a soil binder and mulch on the cutslopes the Location; it was observed that the BMPs are not in proper functioning condition and do not appear to be adequate for the site's conditions; mulch observed to have sluffed off- erosion degradation evident.

BMPs remain insufficient to stabilize and protect the cut slopes

Corrective Action: Corrective action has not been addressed in its entirety and remains applicable: Install or repair required BMPs per Rule 1002.f.(2)C. Ensure control measures are adequate for the site's conditions, installed in accordance with good engineering practices, and maintained in proper functioning condition.
