**General Comment:**

On 7/9/2021 Catherine Roy conducted a followup reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

-Corrective action to control weeds from 2020 reclamation inspection is partially addressed. Approximately 25 Russian knapweeds and 15 musk thistles remain untreated within the interim reclamation area. Areas with infestation are weedy with kochia and Russian thistle that needs to be managed (ie: mowing, pulling) to encourage desirable vegetative cover. Control weeds and revegetate areas with poor desirable cover. Corrective action timing is back-dated to original corrective action date: 6/15/2018.

Comment -Corrective action to control weeds from 2020 reclamation inspection is partially addressed. Approximately 25 Russian knapweeds and 15 musk thistles remain untreated within the interim reclamation area. Areas with infestation are weedy with kochia and Russian thistle that needs to be managed (ie: mowing, pulling) to encourage desirable vegetative cover. Evidence of recent treatment of musk thistles observed.

Corrective Action -Control weeds and revegetate areas with poor desirable cover. Corrective action timing is back-dated to original corrective action date: 6/15/2018 until weeds are controlled and revegetation meets vegetative guidelines in reclamation rules.
