Comment: There is an abandoned pipe riser that remains at the location. All equipment should have been removed within 3 months of abandoning the well. Previous inspection required pipe riser to be removed. The desirable perennial vegetation has not established around the pipe riser area. The riser must be removed and disturbed area around the riser needs to be reclaimed. Previous corrective action date remains. Corrective action must be performed immediately.
