Comment: The location has not been reclaimed and soils are compacted. There is a road that travels thru the location however, disturbed areas need to be reclaimed up to the road as stated in the previous inspection. There is approximately 0.4 acres that needs to be reclaimed back to cropland production. Soils must be decompacted by crossripping to a minimum depth of 18 inches. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately.
