Comment:

There is an area 30ft.x30ft. with no vegetation establishment at the former well site. It appears impacted soils are preventing vegetation establishment. Additional remediation and reclamation needs to be performed to establish vegetation cover. There was also a remediation site (12987) of impacted soils which was not inspected located southwest of the well site. Noxious weeds were observed at the well site which need to be controlled. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately.
