Comment:

There is an associated meter shed which is approximately 500' south of the well site. The meter shed and risers need to be removed. The access road to the meter shed needs to be reclaimed. The area around the meter shed has not re-established vegetation and was a remediation site (15744) of impacted soils. There is an area at the well site with no vegetation establishment which was also documented in the previous inspection. There is likely soil issues at the well site preventing vegetation establishment. There is also weeds in areas at the location. The corrective action date is set for when equipment removal and reclamation was required to be performed. Corrective action needs to be performed immediately.
