Comment: The crop has not re-established at the area of the associated pit located 600 ft. southwest of the well site. There are multiple areas measuring 100ft.x20ft. with no crop growth which indicates impacted soils. The crop at the well site appears to have established. The soils at the former pit need to be reclaimed to support cropland production. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately.
