Photo also shows example where topsoil has been utilized at the base of the fill slopes/subsoils of the Location, as a berm and sediment trap/pond to manage stormwater. Photo shows Topsoil has not been properly separated and protected, is being mixed with subsoil, and is at risk for loss due to stormwater discharge displacing the topsoil. A second trap/pond exists on the east end of the Location.
