#### COMMENTS:

The temporary abandoned status for the subject well is a result of shutting in the Wilson Creek field prior to full field abandonment (Form 4 letter of intent previously filed - Doc #402763821). The production tree will be used as the primary barrier to isolate the well from surface; surface flow lines will be disconnected from the production tree. Tubing, casing and bradenhead pressures will be monitored during shut-in status. Bradenhead pressures will be recorded monthly and Form 17's will be submitted annually leading up to permanent abandonment. The subject well will be added to the well abandonment queue and its shut-in status will be tracked. If the shut-in period is longer than 2 years, a subsequent MIT will be submitted for review and approval. Form 6's will be submitted for approval leading up to final abandonment.
