<p><b>COGCC Inspection Report Summary</b></p> <p>On 07-12-2021 at approximately 1000hrs, I, conducted an inspection of Cub Creek Litzenberger location in reference to a fire which had occurred at location Location # 44819 in Weld County Colorado.</p> <p>The purpose of this inspection was to determine the extent of the damaged caused by the fire at the location. When I arrived I observed the separators on the south end of the location had been damaged by the fire. I observed 5 to six of the horizontal heated separators had been damaged by the fire. I also observed the soil around these separators appeared to have stained soil.</p> <p>Corrective actions of repairing and inspecting equipment and cleaning up stained soil prior to operations of equipment were issued for this inspection.</p> <p>Drone images were taken of location and are attached to this inspection.</p> <p>At the time of the inspection no personnel from Cub Creek where on location to interview.</p> <p>All corrective action from previous and further inspection must be completed to comply with COGCC rules.</p> <p>This is a summary of inspection report.</p>	gomezj	08/02/2021
