COMMENTS:

Approval of alternative MIT is requested per Rule 326.b(3). Braidenhead tests have been submitted annually on the well showing no braidenhead pressure and positive casing pressure. The most recent braidenhead test conducted on 6/10/2021 verified no braidenhead pressure or flow and a casing pressure of 150 psi proving that the wellbore has integrity and no casing leak exists. Well pressures including braidenhead will be monitored monthly to ensure integrity.

The gas pipeline for this well was shut-in in July 2018 due to repair a small leak detected by Western Gas. Western repaired the leak but did not put the line back in service, repeatedly sending notices of delayed pressure testing. They have only recently indicated that they will not be putting the line back in service. Goodwin Energy intends to apply for approval to combust the small amount of gas produced by the well and return it to production.
