Comment: At a minimum, the associated tank battery is not reflective of reference crop areas.

The well location and the majority of the eastern portion of the reference crop field has stunted crop growth (beyond and outside of the well location) when compared to the western portion of the reference crop field. The stunted crop growth observed at the well location and the eastern portion may not be oil and gas related.

Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
