**General Comment:**

On 8/4/2021 COGCC staff, Kris Neidel inspected 081-07227 location, this location is a part of spill 479587 and Remediation # 19550. At the time of the inspection, the spill area had been partially excavated. The area of suspected impact had orange, soil and water. Water was observed in pit had a slight sheen. Recent weather had heavy rain, water is assumed from rain and not groundwater. Corrective Action: the operator should ensure that surface waters are not allowed to enter pit, all water contained in pit shall be handled as E&P waste, A full geological evaluation of the excavation should be completed to determine if suspected impacts are naturally occurring or real impacts from E&P activity, all soils shall comply with COGCC table 915-1, a roll of chicken wire was observed off the pad and should be removed as trash/debris.
