 Field Inspector Actions:  
 On 8/9/2021 I received a complaint concerning noise suspected to be coming from the Knight Pad, operated by Cub Creek Energy  
 On 8/10/2021, I deployed sound auditing equipment approximately 350' from the Knight Pad sound walls in the direction of the complainants address (40.19757, -105.04376).  
 The sound audit continued through 8/13/2021 at 12:28:00.  
 Averages below have been calculated by subtracting data with wind speeds at or above 5mph. See weather data attachment for weather detail.  
 See day and nighttime sound audit attachments for data details.  
 Sound levels were observed to be:  
 Daytime DB-A Average: Overall 60.9DB -Adjusted for weather and timeframe 57.8 DB  
 Daytime DB-C Average: Overall 76DB -Adjusted for weather and timeframe 74.5  
 Overnight DB-A Average: Overall 60.9 -Adjusted for weather and timeframe 61.1DB  
 Overnight DB-C average: Overall 76 -Adjusted for weather and timeframe 76.7DB  
 The levels observed overnight for DB-A over the course of the study suggest non-compliance under COGCC rule 423-1 (2) A.  
 The levels observed overnight for DB-C over the course of the study suggest non-compliance under COGCC rule 423-1 (2) B.  
 All information reviewed and site inspection information were submitted to the complaint specialist for further review.
