Comment: There was maintenance of BMP's performed however a significant storm event has caused additional maintenance issues. The cattle guard has filled in with sediment. The cut slope of the road is eroded and not stabilized. Stormwater is directed down the road causing erosion of the road. BMP's must be implemented in accordance with good engineering practice and must be maintained until final reclamation is achieved.
