General Comment:

On 8/6/2021 Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

-Stormwater BMPs and erosion controls need to be installed to stabilize erosion and prevent sediment discharge from the project area, no later than 9/15/2021.

-Tank containment berms are eroding, resulting in reduced capacity, and are inadequate to contain fluids. Repair or install berms or other secondary containment devices per Rule 603.o. by 9/15/2021. Berms need to be stabilized to prevent erosion and sediment discharge.

Comment: Erosion is occurring on well pad cut slopes and berms, as well as along the access road where down-cutting, sedimentation, and scouring is observed.

Corrective Action: -Stormwater (ie: BMPs) and erosion controls (ie: erosion control blanket, hydromulch, etc.) need to be installed to stabilize erosion and prevent sediment discharge from the project area, no later than 9/15/2021. Controls need to be selected, sized, installed, and maintained according to good engineering practices such as those described by CDOT in their erosion control manuals.
