#### COMMENTS:

On 06/29/2021, a Form 17 (DOC #402733133 attached) was completed with a beginning pressure of 236 psi and ended with 1 psi at the end of the 30 minute test. Chevron will plumb the surface casing into the flowline as is seen on the attached diagram by 10/29/2021. This will maintain the pressure below the 230 psi limit as flowline pressure ranges from ~80-140 psi.
