Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

After pressuring up the P6 Lateral for a pressure test, the pipeline operator noticed the pressure dropping on the line. He drove the ROW looking for signs of a leak and found a spot where the vegetation was starting to die. He verified the leak with the FLIR camera (OGI device). There is no liquid on the ground. This line is an 8 inches in diameter and 1,320 ft. long. The GPS coordinates for the leak are -107.702 and 39.470. The Operator locked out the line and blew it down. We will schedule a line repair with construction.
