**Contractor:**

- I have contracted Wood with staff from their Denver office as the reclamation contractor for this site. Richard Weber (in copy) is the Project Manager for Wood.
- Richard and his team are planning to perform a site survey with the objective of developing a geotechnical plan as well as preliminary requirements for a reclamation plan. The site survey is planned within the next couple of weeks.
- Following up from this initial site survey we will contract you, as well as the landowner, to discuss forward developments for the geotechnical / reclamation plans.

**Landowner:**

- The landowner for this site is Bobby Hill who owns Hill Ranches. This site is located on one of his big game hunting ranches.
- I spoke with Mr. Hill and he verbally agreed to Wood's site survey.
- Mr. Hill made it very clear that we are not allowed access for this site from mid-August thru November which of course we will respect.

- Also in this conversation Mr. Hill did not want to discuss signing a formal land access agreement for heavy equipment access to perform the geotechnical study and ultimately reclamation of the site. This could be a risk to delivering this project as we will require a formally authorized agreement with the landowner to perform work on their property.

**Sundry Notice:**

- The previous delays to this project (company restructure & Covid-19) have been slow to lift but my current concern is denied equipment access by the landowner.

We appreciate the detailed and thorough plan provided. The COGCC cannot approve a reclamation plan, but the plan appears to address compliance towards the reclamation requirements.

There is a question regarding the seeding rate specification. The table 8. indicates PLS per acre which seems incorrect. Typically for broadcast seeding we see 75-100 PLS/sqft. Is the table indicating seeds per sqft or pounds per acre?

I look forward to seeing the reclamation take place.

Thanks for your response and thank you for catching the error on Table 8. That should read "pounds per acre" Because we plan to hydroseed, the pounds per acre are slightly less than needed if broadcast seeding. Please let me know if you have any further comments or recommendations. Thank you.
