On 8/26/2021 Catherine Roy conducted a followup reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

- Corrective actions identified during the May 2021 reclamation inspection are not addressed as dense weeds and debris remain around the tank battery area. Corrective action is back-dated to 5/30/2021 to document duration of non-compliance. It is the expectation that corrective action be addressed immediately.
- Spotted knapweeds need to be controlled by 9/30/2021.
