Comment: The road was graded and culvert maintenance has been performed. There are areas of the road that are still not stabilized after recent grading operations. There is vehicle rutting and stormwater is not properly diverted. Repairing the road only by grading is not sufficient. Areas of erosion along the access road must be repaired and properly stabilized. This issue has been previously observed and needs to be prevented. BMP's must be implemented in accordance with good engineering practice and must be maintained. Previous corrective action has not been completed.
