Comment Operator has performed interim reclamation activities; however, the size of the location can be further reduced in size. More specifically, the eastern location utilized for facility storage can be further reduced in size. Some of the southwestern area may be currently needed for vehicle traffic; however, Operator should reconsider repositioning the location entrance to help further reduce the size of the southwestern area. Refer to the attached inspection photos.

Corrective Action Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards, including stormwater and weed management.

Interim reclamation activities shall be complete no later than 11/15/21 or as soon as environmental conditions will permit.
