#### COMMENTS:

TEP Rocky Mountain LLC (TEP) is reporting that the bradenhead on the W-46-11 well has been connected to the sales line as part of a Pressure Management Plan. On 9/3/2021, the W-46-11 had a bradenhead pressure of 169 psi. This well has a surface casing depth (TVD) of 344' giving the well a calculated threshold pressure of 103 psi. TEP performed a blowdown test and submitted the test results via a Form 17 on 9/7/2021. A copy of the Form 17 is included in the "Related Forms" section. TEP monitored the bradenhead pressure after performing the test and determined that the bradenhead pressure continued to build and sustain pressures above the calculated threshold pressure. On 9/9/2021, TEP connected the bradenhead to the sales line as part of a Pressure Management Plan for this well. This well only makes ~3 Mcf/day and no fluid so it does not flow through a separator. The bradenhead was connected straight into the sales line. The bradenhead was connected to the sales line with a 3/8" steel pipe and a check valve. The average sales line pressure for this well is 49 psi. A typical diagram is attached which depicts the bradenhead connection.
