On Wednesday 9/15/21 at approximately 14:30 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC UNOCAL-67S96W /2NWNE, Location #323884 in Garfield County Colorado.  
While there, I observed normal production operations.  
During this inspection the following compliance issues were observed:

- 1) Horizontal separators includes glycol storage tank. Glycol storage tank is approximately 2'x3'x10' with an approximate capacity of 11 barrels. Glycol storage tank missing required information with a corrective action date of 12/15/21.
- 2) Location lacks stabilization. Insufficient tracking BMP at entrance to location with a corrective action date of 9/30/21.

- Location is located in a high priority habitat area all drainages contributed to Parachute creek.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
