**General Comment:****COGCC Inspection Report Summary**

On Tuesday 9/21/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus Mallard 4804, at Location # 316239 in Rio Blanco county Colorado.

While there, I observed well was shut in. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

During this inspection the following compliance issues were observed:

1. One horizontal unit separators includes 1 glycol storage tank, approximately 33" x 84" x 36" = 10.28 BBLs each, storage vessel contains no labeling to specify capacity or chemical hazard information.
2. Access road has multiple locations of erosion, lack of compaction and weeds  
Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
