Comments:

The former CRESTONE 6-8 well (API: 05-125-11437) was P&A'd on February 26, 2009, as identified in the Form 6 Document Number 01799270. On July 16, 2021, WSP conducted a final reclamation inspection for the former CRESTONE 6-8 well (Location ID: 311044). The reclaimed well pad is now located on an agricultural field for growing crops. WSP personnel located the P&A wellhead location using a handheld Trimble (R1) Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the COGCC online database. A general site location map is included as Figure 1; and the Site Map displaying the location of the reclaimed site on aerial imagery is included as Figure 2. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location.
