General Comment:**COGCC Inspection Report Summary**

On Wednesday 9/15/2021 at approximately 1200, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus H35, at Location # 335003 in Garfield county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

During this inspection the following compliance issues were observed:

1. A vertical unit separator includes 1 glycol storage tank, approximately 48" x 72" x 80" = 28.49 BBLS each, storage vessel contains no labeling to specify capacity or chemical hazard information.

2. Lack of bull plugs

3. Lack of battery sign
