KPK will removed all impacted media and replace with clean media. KPK does not anticipate groundwater impacts at this time, however if ground water impacts are observed after sampling, KPK will update this project with a remediation plan.

Flowline failure occurred due to 3-inch fiberglass pipe failure. Reason(s) for failure is unknown. 3-inch fiberglass pipe failed in the 12 o'clock position, where a fracture in the pipe was observed. An estimated 30 ft. section of fiberglass pipe has been removed for excavation activities.

Following the approval to backfill, KPK will backfill up to the flowline to make necessary repairs. KPK will install new section of 3-inch fiberglass pipe to reconnect flowline. Flowline will be pressure tested following the completion of repair work.

KPK will collect a composite sample from stockpiled material to determine if soil can be used for backfilling. KPK will analyze the sample for full Table 915-1 compliance. if there are exceedances (taking into account background sample results), KPK will dispose of soil at a certified disposal facility.

KPK is requesting permission to backfill prior to submitting a request for closure.

See attached documents for all information related to completion of clean up.

Please note there is a clean stockpile on location. KPK had to excavate a ramp to allow the excavator into the excavation. The stockpile is the clean soil from the initial ramp construction. Recent heavy rains may have left the sidewalls of the excavation unstable, KPK strongly discourages entering the excavation without proper safety measures. KPK will make every effort to have personnel or equipment on location for safety if COGCC staff want to enter the excavation.

This is a resubmittal of 8/17/2021 Form 27 (Doc #402777901). Supporting documentation for request to backfill should be referenced in prior Form 27 submittal. The 9/3/2021 resubmittal is to provide flowline failure and corrective action information from FIR Doc #693700764. Flowline information provided for the COGCC Engineering Integrity Group can be found in the Remediation Summary Section of the Remedial Action Plan.
