Unfortunately, due to the ongoing pandemic, Citation has been unable to locate a crew to remove and replace the tank. Given the work crew shortage to perform this work, it is difficult to estimate when this existing tank may be removed and replaced. Until, that time, the tank will remain logged and tagged out of service.
