Corrective Action:	<p>The well location and associated access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.</p> <p>The tank battery location does not comply with Rule 1004. Limited desirable species were observed within the disturbance area. Heavy equipment tracks and bareground were observed throughout the area and a pile of manure was located onsite.</p> <p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be completed in such a manner as to not interfere with agricultural activities or crop production.
