 The next nearest water well is ~1000' SE of the North Platte 22-24 wellhead (DWR Receipt #0014361). Well was permitted but never drilled, static water level not recorded. The third closest well is ~1600' NE of the flowline end point (DWR Receipt #9063557). This residential well depth is 172 ft, the static water level is 112'. Groundwater less than 20 ft is not expected at the disturbance location.
 This location is within a HPH Pronghorn Winter Concentration Area.

All samples collected for lab analysis were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
