INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with COGCC Rule 911, this form serves as notification for decommissioning and abandonment of the McKenney 6-42 wellhead and removal of the associated flowline. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts during equipment decommissioning. Field observations and photo documentation will be recorded in a field inspection form for submittal to the COGCC.

Proposed Soil Sampling

Soil samples will be collected from the surface in cardinal directions of the wellhead, as defined in the Rule 911.a.(4) guidance document (1/4/21), for field screening purposes. Discrete soil samples will be collected for laboratory analysis either in any area of observed hydrocarbon impacts, or adjacent to the cut and capped wellhead from native material and below the flowline riser. GPS data will be collected for all soil sample locations. Soil samples will be submitted for laboratory for analysis of Organic Compounds in Soil, TPH (C6-C36), and Soil Suitability for Reclamation by COGCC approved methods. Refer to the Wellhead and Flowline Location Map.

If groundwater is encountered during decommissioning and/or abandonment activities at designated laboratory sample locations, a grab groundwater sample will be collected as soon as practical. If groundwater is encountered at designated field screening sample locations, a groundwater sample will not be collected unless field screening indicates that potentially hydrocarbon-impacted soils are present. If contaminated soil is in contact with groundwater, or if free product/hydrocarbon sheen is observed, the release will be reported in accordance with Rule 912.b. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260.

Additional Investigative Actions

An assessment will be conducted during the removal of this off-location flowline (estimated to be 745 feet in length), with an emphasis in the areas where the flowline is in close proximity to sensitive areas, such as drainage/surface water crossings, High Priority Habitats, and FWS wetlands. The flowline and adjacent sub-surface will be inspected for any visual and olfactory indicators of potential failure and hydrocarbon impacts. Soils will be field screened below the flowline and if suspected impacts are observed, a soil sample will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, and TPH (C6-C36) by EPA Methods 8260B and 8015. GPS data and photo documentation will be recorded for each inspection/sample location. A sample location figure will be provided in the Supplemental Form 27.

On August 10, 2021, two background samples (BKG01 @ 4' and BKG01 @ 6') were collected from native material topographically upgradient of the wellhead location and submitted for analysis of pH. Analytical results indicated that pH was in exceedance of the applicable Table 915-1 standard in native material at both depth intervals of 4' and 6'.

No soil was removed from the location during wellhead closure activities and the removal of the associated flowline.

REMEDIAL SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Soil encountered adjacent to and surrounding the wellhead and below the flowline riser was visually inspected and field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID). In addition, field screening samples were collected, and inspections conducted along the flowline every 250 feet and below the flowline risers. Per the approved proposed soil sampling plan, two soil samples were collected at approximately 4 feet and 6 feet below ground surface (bgs) from undisturbed areas most likely to be impacted by oil and gas operations located adjacent to and below production infrastructure. Soil samples FLR01 and WH01 were submitted for laboratory analysis of the Table 915-1 Organic Compounds in Soil, TPH (C6-C36), and Table 915-1 Soil Suitability for Reclamation. Analytical results indicated that pH was in exceedance of the applicable COGCC Table 915-1 standard in sample FLR01. Consequently, two background soil samples (BKG01 @ 4' and BKG01 @ 6') were collected from native material topographically upgradient of the wellhead location and submitted for analysis of pH. Analytical results indicated that pH was in exceedance of the applicable standard in native material in both background samples. Based on the results, organic compound concentrations and inorganic parameters are in compliance with the regulatory standards. Analytical results are summarized in Tables 1 through 3, and GPS coordinates and field screened VOC concentrations are summarized in Table 4. Field screening and laboratory sample locations collected at the wellhead and along the flowline are illustrated on Figures 1 and 2. The laboratory report is included as Attachment A and the wellhead closure and flowline removal field notes and photo log are included as Attachment B.
